



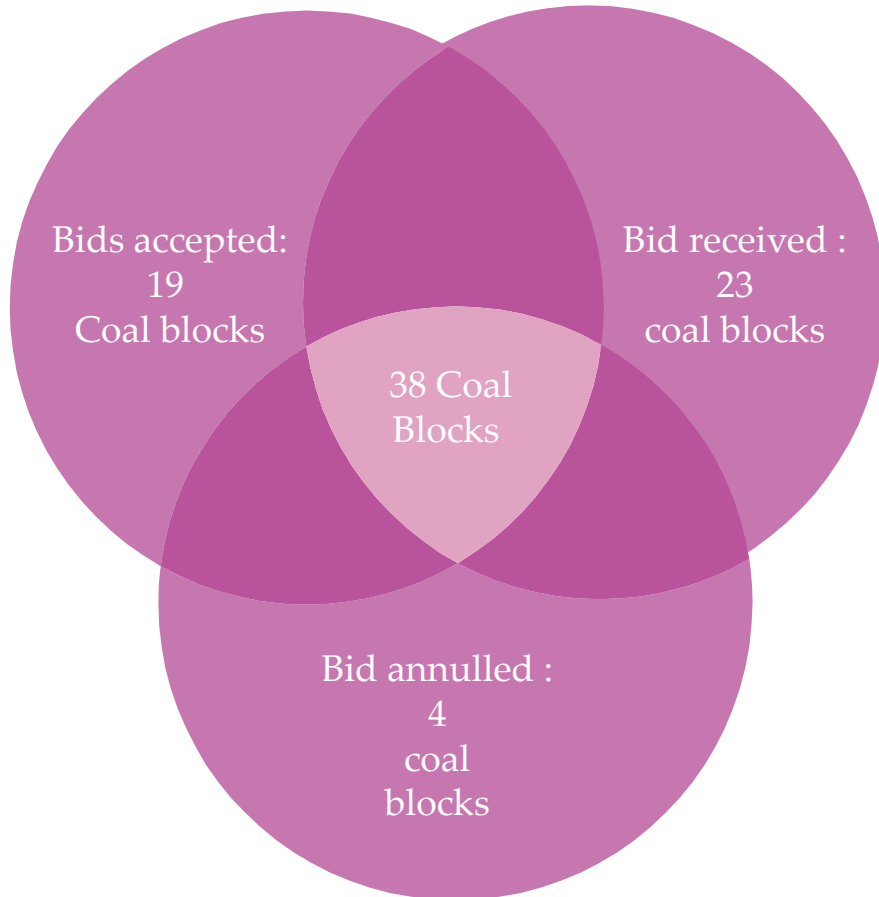

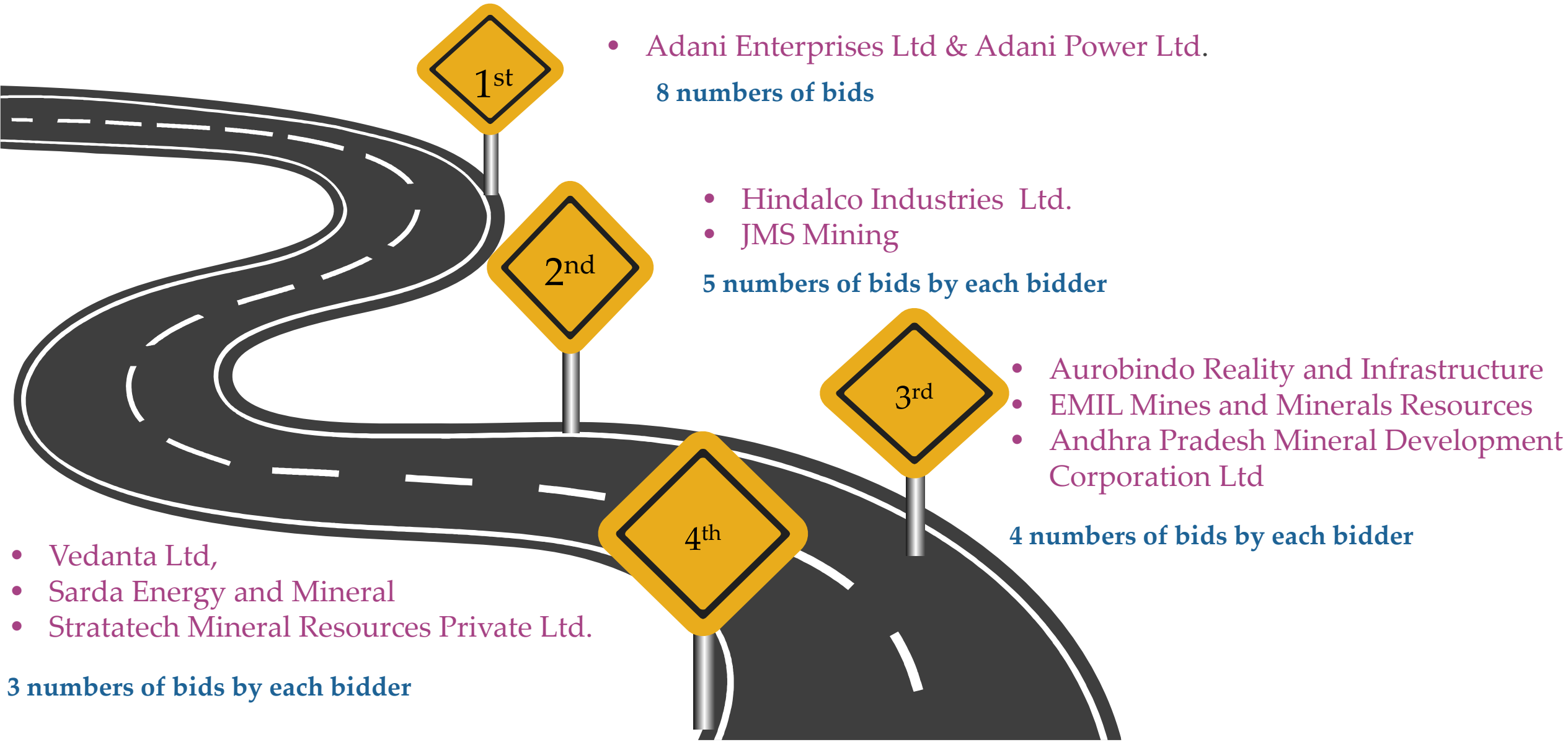

- On 30th September 2020, the Nominated Authority, Ministry of coal, GoI has opened technical bids submitted by 42 bidders for revised 38 numbers of coal blocks for commercial coal mining.
- A total of 76 bids have been received from 42 companies for 23 coal blocks that were put up for auction under commercial mining.
- Only one Technical Bid has been received for Chendipada & Chendipada-II , Kuraloi (A) North and Seregarha Coal Blocks. Due to submission of single bid, the tender process for the said Coal Blocks have been annulled as per tender conditions.
- No bids have been received for 15 blocks, namely, Chitarpur, Choritand Tiliaya, Machhakata & Mahanadi, Marki Barka, North Dhadu, Shankarpur Bhatgaon II Extn., Sondhia, Thesgora-B/ Rudrapuri, Brahmanbil & Kardabahal, Dolesara, Jarekela, Jharpalam-Tangarghat, Marwatola Sector-VI & Sector-VII and Phuljhari (East & West).

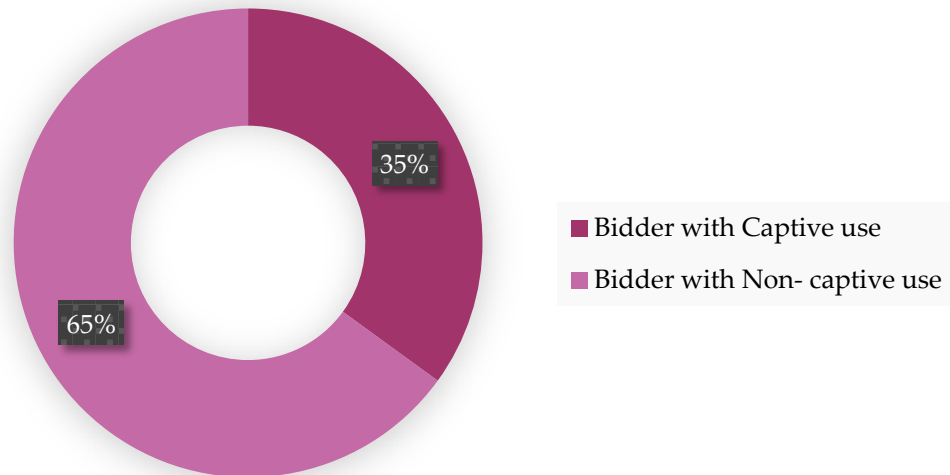
# Highest Number Of Bids Submitted By Bidders



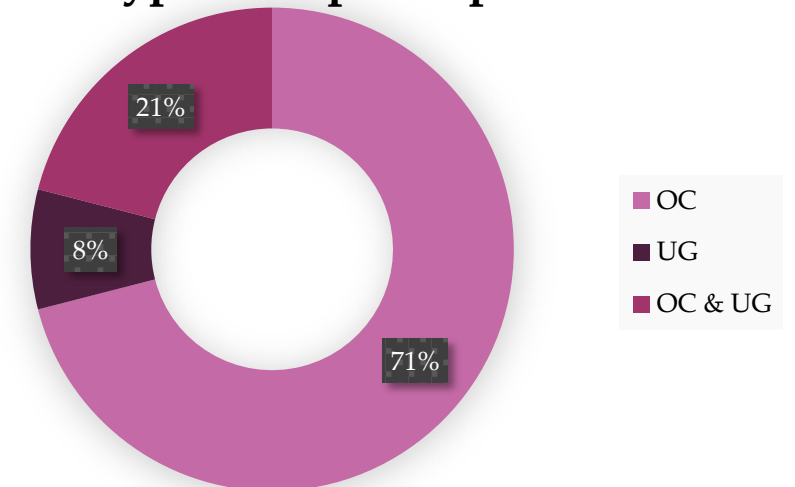
